Thank you for your email regarding the proposed residential development at Hillside, Wooley Bridge. I would advise you that as the proposed development is only for 6 dwellings, the development would not be considered to be of strategic planning policy significance from the County Council's point of view and it would be unlikely that the Borough Council would seek the County Council's planning policy comments on the application. The County Council is also consulted on planning applications for residential development of 10 dwellings or more to consider the likely infrastructure contributions that would be necessary to make a scheme acceptable, particularly contributions to education provision. Again in this case, the proposed development would fall below the 10 dwelling threshold and would therefore be unlikely to raise any infrastructure contribution issues for the County Council

With regard to the landfill issue, I have checked the County Council's historic records for landfill operations in the vicinity of the proposed site. The only planning history of note is that the railway embankment to the east of the site was subject to a proposed reclamation scheme in the early 1990s, which included the importation of waste which was granted a site licence in January 1991 from the County Council, which at that time had responsibility for licencing for waste sites (see attached). The last records of the County Council, indicate that this permission was not implemented. However, responsibility for the licencing of waste sites was subsequently transferred to the Environment Agency in the early 1990s. I would advise you therefore to contact the Environment Agency for information and advice on the landfill issue you refer to and whether the EA would require any supporting information on contamination to be submitted with the planning application.
