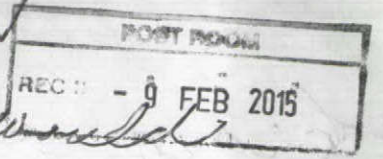


TO DEVELOPMENT CONTROL SECTION

for a bungalow next to BUK

Craig on Eccles Road was refused by The Planning Authority because Eccles Road was too narrow and has no footpath; and this would also apply on the top side of Eccles Road.

3. There has now been a marked increase in the number of cars on Eccles Road and Crossings Road since that time and especially on Eccles Road dangerous for young and old walking on the road.
4. The function of Eccles & Crossings

road has had vision, and a
 machine to assist was loaned by
 the Council and it is only a
 matter of time before there is
 a serious accident as both
 roads are very busy.

5. There is a stile and right
 of way through the field
 where the houses have been
 requested.

6. There is no room for parking
 on the narrow Beles Road and
 cars have to draw into the
 road to let unpowered cars pass.

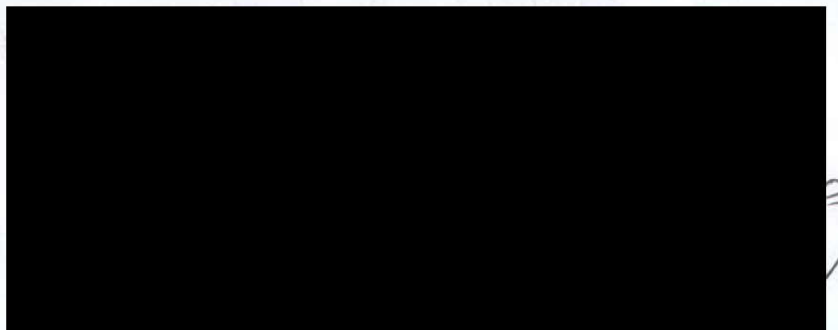
At 97 I have no need to

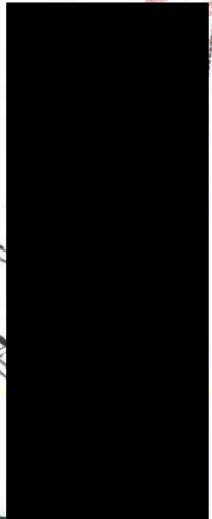
