**Planning Application No. HPK/2015/0341**

I refer to the above planning application by which the owners of the Pico Lounge at Howard Town Mill, Glossop seek the removal of Condition 11 from their current Planning Permission. This condition precludes the playing of amplified music or noise within their building outside the hours of 9.00 and 22.00 each day and outside the building at all times.

When the current permission was granted we did not object to the development but we sought several Planning Conditions to preserve the environment in which we live. The imposition of the Planning Condition which is now the subject of this new application was one of those.

The Lounge have been quite acceptable and decent neighbours from when the Lounge opened. We believe that the planning condition made a material contribution to achieving this. We wish that to continue.

We therefore object to the removal of the Planning Condition 11. We are especially concerned that there should NOT be any amplified music or noise outside the building and at the back on their patio area at any time. We urge the refusal of this new application.
