Please find attached the Appropriate Assessment as required by Natural England. It seems to address all the matters raised by NE.

I would like to add one comment myself. NE raised the matter of "Water Quality impacts from the proposal (to take into consideration foul and surface drainage) in relation to The Peak District Dales SAC downstream of the proposal". The AA considers this to be unlikely, which is reassuring. Nevertheless, given that the details for foul and surface water drainage are reserved matters, I wonder whether this is really an issue for the outline stage.
