I understand a revised application has been lodged by Gladman and I should like to register my objection to these proposals on the following grounds:

It fails to address the increased traffic congestion that the proposals will create. The siting of a new access point on Macclesfield Road is totally unsuitable and potentially very dangerous. It will not be just cars using this access but large delivery vehicles which will have difficulty turning.

It will mean the loss of amenity for local residents and will inevitably put residents' safety in jeopardy.

Parking issues on Macclesfield Road and other roads in the vicinity will become ever more critical with any increased traffic generation and even without the additional development require urgent remedy.

Further afield, increased pressure on local schools and shops will mean that access from Horwich End into Whaley Bridge will become even more difficult and unsafe. Even without the development, the situation is extremely demanding at peak times with traffic trying to negotiate a way through parked vehicles on both sides of the main road. Buses and Emergency vehicles have already become 'trapped' in this congested spot and further local traffic can only increase these incidences.

To consider increasing traffic volume along this stretch of road as well as along Macclesfield Road which new housing will create would be very foolhardy and not in the interests of the environment, amenity or the safety of the residents of Whaley Bridge.

Accordingly, I trust the recommendation to the Council will be to refuse the revised planning application and that the Members will reject Gladman's proposals for this site.
