Good morning Faye,

I have read the Environmental Health-Planning Consultation from Mr. Matthew Rhodes. and wish to comment as follows:

## Condition 1 Contaminated Land

The contaminated land is from an integrity inspection conducted on the two UST's in 2004.

Four inspection holes were dug and one hole found traces of oil contamination which identified the second UST had failed and was subsequently decommissioned by having the existing oil removed from site, the tank was then cleaned and completely foam filled.

We have in place a contractor to remove from sie the oil in the remaining UST, to clean the tank and then fill with concrete. On completion of these works we will dig more inspection holes in the local facinity to investigate for contaminated land and to remove from site when identified.

The Asbestos identified from Mark Bullocks survey (2017) and previous Environ surveys have identified the same and the removal of these items are simple with the correct precautions being conducted.

The site has had no activity on it for very many years and previously only had oil in the area where the two UST's are sited.

It is not our intention to have contamination on site or to generae any for he local area. However the requirements being requested appear excessive when one considers this paticular site and its history.

With the above in mind and some of the surveys we have already had conducted are we abl to consider a lesser method to meet the overall requirements?
