Dear Mr Norbury,

Thank you for coming in to the duty planning surgery this afternoon.

In principle, the Council will be able to support a planning application for your replacement windows, within the Conservation Area.

I have attached the application form which you will need to complete, in order to submit your application. As discussed, at present there is no charge for submitting a planning application in a Conservation Area but this is due to change in the near future.

Alongside the planning application you will require some plans to be drawn up to show us the proposed elevations. These can be very simple and do not to be extremely detailed or coloured. Unfortunately we cannot accept a photograph of the building in place of a scale plan, as measurements need to be taken from the plans, which are accurate.

Having spoken again to the Conservation Officer, we can accept UPVC windows within the Conservation Area, as long as they have the wooden replica grain, which you spoke about.

Finally, in terms of the front door we would like to see a traditional front door, which can have windows in if you wish. I have copied a good example of a door below, so that you can see what we would be looking for.




